| US citizen; 18 years of age or older on the first day of the term to be filled at the election; must not have been determined by a final judgment of a court exercising probate jurisdiction to be: (A) totally mentally incapacitated; or (B) partially mentally incapacitated without the right to vote; must not have been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities; must have resided continuously in the State of Texas for 12 months preceding the deadline for filing an application for a place on the ballot; must be a registered voter in the territory from which the office is elected as of the date of the filing deadline for a candidate's place on the ballot. Candidates for Mayor must have resided within the city limits for at least 12 months preceding election day. | First day to file: January 14, 2026<br><br>Last day to file: February 13, 2026                         |
